PARTICIPANT ACKNOWLEDGMENT, RELEASE, WAIVER AND INDEMNITY

In consideration of the benefits I derive from participation in travel or other events sponsored by Community National Bank ("CNB") through its Community Circle club, I acknowledge and agree as follows:

- **Community Circle Travel Policy.** I acknowledge that I have received a copy of the Community Circle Travel Policy and I agree to all the terms and conditions of the Policy.
- **Acceptance of Inherent Risk.** I understand that travel and participation in other physical activities entail inherent risks, dangers and hazards, all of which I accept and assume with respect to any Community Circle sponsored trip or other activity in which I choose to participate.
- **Limitation of Liability; Waiver and Release of Claims.** On behalf of myself and my personal representatives, heirs and assigns, I hereby fully and completely waive and release any claims I may have, now or in the future, against CNB, the Community Circle Director, and the employees, officers, directors, agents and affiliated companies of CNB (the "**Released Parties**") arising directly or indirectly as a result of (1) any wrongful, negligent, willful or unauthorized acts or omissions on the part of any supplier of goods or services for a Community Circle sponsored trip or other activity ("**Vendor**") or their officers, employees or agents; (2) any defect in or failure of any vehicle, equipment, instrument or facility owned, leased, operated or otherwise used by Community Circle or any such Vendor in connection with any Community Circle sponsored trip or other activity; or (3) any wrongful, willful or negligent act or omission on the part of any other party not under the supervision and control of CNB in connection with any Community Circle sponsored trip or other activity. Further, I agree not to bring any claim or suit against any of the Released Parties for any act or omission on their part relating, directly or indirectly, to Community Circle or to my participation in any Community Circle sponsored trip or other activity, except to the extent such act or omission constitutes gross negligence or willful malfeasance by such Released Party.
- **Indemnification for My Own Acts or Omissions.** I agree to indemnify, defend and hold harmless each of the Released Parties (as defined above) with respect to any claim, liability, expense or cost in connection with any loss, damage or injury to any other person or their property resulting, directly or indirectly, from my own acts or omissions.

- **Publicity Release.** I give my consent to CNB, its parent company, Community Bancorp., and their officers, directors, employees and agents, to take photographs and make audio and/or video recordings of me while participating in any Community Circle sponsored trip or other activity, and to use and publish my name, likeness, photographs and recordings, in all forms and all media, in connection with their business and promotional activities, including, without limitation, posting on the CNB website and/or FaceBook page and publication in the CNB Newsletter. *[NOTE: If you do not wish to provide this Publicity Release or wish to revoke it at any time in the future, you may do so by notifying the Community Circle Director in writing at: Community National Bank, 4811 US Route 5, Newport, VT 05855, Attn: Community Circle Director.
